The San Jacinto Wilderness is located in the San Bernardino National Forest, Riverside County, California. The following description refers to the attached one inch equals one mile scale map titled "San Jacinto Wilderness" and dated July 1987. The boundary description covers those lands designated the San Jacinto Wilderness by P.L. 88-577 and P.L. 98-425.

Northern Portion

Beginning at the northwest corner of Section 27, T.3S., R.2E., San Bernardino Base and Meridian.

Thence, easterly along the north boundary of Sections 27, 26, and 25 (excepting that area necessary for a powerline corridor should a powerline be constructed as allowed for by P.L. 98-425) to the northeast corner of Section 25, T.3S., R.2E.;

Thence, northerly along the west boundary of Section 30, T.3S., R.3E., (excepting that area necessary for a powerline corridor should a powerline be constructed as allowed for by P.L. 98-425) to the northwest corner of Section 30;

Thence, easterly along the north boundary of Sections 30 and 29 to the northeast corner of Section 29;

Thence, southerly along the east boundary of Section 29 to the southeast corner of Section 29;

Thence, easterly along the north boundary of Sections 33, 34, and 35 to the northeast corner of Section 35;

Thence, southerly along the east boundary of Section 35, T.3S., R.3E., to the north boundary of Section 1, T.4S., R.3E.;

Thence, easterly along the north boundary of Section 1 to the northeast corner of Section 1;

Thence, southerly along the east boundary of Sections 1 and 12 to the E1/4 corner of Section 12;

Thence, westerly along the south boundary of the N1/2 of Section 12 to the W1/4 corner of Section 12;

Thence, southerly along the east boundary of Section 11 to the southeast corner of Section 11;

Thence, westerly approximately 5 miles along the south boundary of Sections 11, 10, 9, 8, and 7 to the southwest corner of Section 7, T.4S., R.3E.;

Thence, southerly along the east boundary of Sections 12 and 13, T.4S., R.2E., to the N1/16 corner on the east boundary of Section 13;

Thence, westerly along the south boundary of the N1/2N1/2 of Section 13 to the N1/16 corner on the west boundary of Section 13;

Thence, northerly along the west boundary of Sections 13 and 12 to a point 300 feet south of a road (known as Forest Service Road 4S01);

Thence, easterly along a line 300 feet south of and parallel to the road (known as Forest Service Road 2S01) to a point 300 feet south of the easternmost extension of the center line in the NW1/4 of Section 12;

Thence, easterly to the C-N1/16 corner of Section 12;

Thence, northerly along the west boundary of the NW1/4NE1/4 to the N1/4 corner of Section 12;

Thence, easterly along the north boundary of Section 12 to the northeast corner of Section 12, T.4S., R.2E.;

Thence, northerly along the west boundary of Sections 7 and 6, T.4S., R.3E., to the southeast corner of Section 36, T.3S., R.2E.;

Thence, westerly along the south boundary of Section 36 to the S1/4 corner of Section 36;

Thence, northerly along the west boundary of the SE1/4 to the C1/4 corner of Section 36;

Thence, westerly along the south boundary of the N1/2 of Sections 36 and 35 to the E1/4 corner of Section 34;

Thence, southerly along the east boundary of Section 34, T.3S., R.2E., and Section 3, T.4S., R.2E., to the E1/4 corner of Section 3;

Thence, westerly along the south boundary of the N1/2 of Section 3 to the W1/4 corner of Section 3;

Thence, northerly along the west boundary of Section 3, T.4S., R.2E., and Sections 34 and 27, T.3S., R.2E., to the northwest corner of Section 27, T.3S., R.2E., the point of beginning.

#### Southern Portion

Beginning at the southwest corner of Section 35, T.5S., R.3E.;

Thence, northerly along the west boundary of Section 35 to the NW1/16 corner of Section 35;

Thence, easterly along the north boundary of the S1/2NW1/4 to the C-N1/16 corner of Section 35;

Thence, northerly along the west boundary of the NE1/4 of Section 35 and the E1/2 of Section 26 to the S1/4 corner of Section 23;

Thence, westerly along the south boundary of Sections 23 and 22 to the southwest corner of Section 22;

Thence, northerly along the west boundary of Section 22 to the northwest corner of Section 22;

Thence, easterly along the north boundary of Section 22 to the northeast corner of Section 22;

Thence, northerly along the west boundary of Section 14 to the W1/4 corner of Section 14;

Thence, westerly along the south boundary of Sections 15 and 16 to the C1/4 corner of Section 16;

Thence, southerly along the east boundary of the SW1/4 of Section 16 to the S1/4 corner of Section 16;

Thence, westerly along the south boundary of Sections 16 and 17 to the S1/4 corner of Section 17;

Thence, northerly along the west boundary of the E1/2 of Sections 17 and 18 to the N1/4 corner of Section 8;

Thence, easterly along the north boundary of Section 8 to the southwest corner of Section 4;

Thence, northerly along the west boundary of Section 4 to the northwest corner of Section 4;

Thence, westerly along the north boundary of Section 5 to the E-E1/64 corner of Section 5;

Thence, southerly along east boundary of the W1/2NE1/4NE1/4 to the C-E-NE1/64 corner of Section 5;

Thence, westerly along the south boundary of the N1/2N1/2 of Section 5 to the N1/16 corner on the east boundary of Section 5;

Thence, northerly along the west boundary of Section 5 to the northwest corner of Section 5;

Thence, easterly along the north boundary of Section 5, T.5S., R.3E., to the southwest corner of Section 32, T.4S., R.3E.;

Thence, northerly along the west boundary of Section 32 to the northwest corner of Section 32;

Thence, easterly approximately 5 miles along the north boundary of Sections 32, 33, 34, 35, and 36 to the northeast corner of Section 36;

Thence, southerly along the east boundary of Section 36, T.4S., R.3E., and Section 1, T.5S., R.3E., to the southwest corner of Section 31, T.4S., R.4E.;

Thence, easterly along the south boundary of Section 31 to the northwest corner of Section 6, T.5S., R.4E.;

Thence, southerly approximately 5.4 miles along the west boundary of Sections 6, 7, 18, 19, 30, and 31, T.4S., R.4E., to the E1/4 corner of Section 36, T.5S., R.3E.;

Thence, westerly along the south boundary of the N1/2 of Section 36 to the northeast corner of the W1/2SE1/4 of Section 36;

Thence, southerly along the east boundary of the W1/2SE1/4 of Section 36, T.5S., R.3E., and the W1/2NE1/4 of Section 1, T.6S., R.3E., to the C-E1/16 corner of Section 1;

Thence, westerly along the east-west center line of Section 1 to the C1/4 corner of Section 1;

Thence, southerly along the north-south center line of Section 1 to the C-S1/16 corner of Section 1;

Thence, southwesterly to the high point of a knoll in the S1/2SW1/4 of Section 1 (See Exhibit A for better contour definition.);

Thence, southwesterly in a straight line to the intersection of an intermittent stream with the 4800-foot contour in the NE1/4SW1/4SW1/4 of Section 12 (See Exhibit A for better contour definition.);

Thence, southwesterly along the 4800-foot contour to the west boundary of Section 12 (See Exhibit A for better contour definition.);

Thence, southerly along the west boundary of Section 12 to the north boundary of Section 13 (See Exhibit A for better contour definition.);

Thence, easterly along the north boundary of Section 13 to the thread of an intermittent stream in Fobes Canyon (See Exhibit A for better contour definition.);

Thence, southwesterly descending the thread of the stream to a point due south of a high point of elevation 4,609, said point being in the E1/2W1/2 of Section 14 and said high point being in the SW1/4 of Section 11;

Thence, due north to said high point in the SW1/4 of Section 11;

Thence, northwesterly in a straight line to an unnamed high point of elevation 4,897 feet in the SW1/4NE1/4 of Section 3, T.6S., R.3E.;

Thence, northeasterly on a ridge to the point of intersection with the south section line of Section 34, T.5S., R3E.;

Thence, easterly along the south boundary of Section 34 to the southwest corner of Section 35, T.5S., R.3E., the point of beginning.
