

## SOUTHERN NANTAHALA WILDERNESS BOUNDARY DESCRIPTION

The Southern Nantahala Wilderness is located on the Chattahoochee and Nantahala National Forests. The eastern portion on the Chattahoochee National Forest in Georgia is in northeastern Rabun county, Georgia and the western portion on the Chattahoochee National Forest in Georgia is in northeastern Towns county, Georgia. The North Carolina Portion on the Nantahala National Forest is in Clay and Macon counties, North Carolina.

### The Chattahoochee National Forest "East" and "West Portions"

The Boundary is delineated on a map scale of (2) inches = 1 Mile or 1:31,680 reduced from Georgia-North Carolina U.S.G.S. 1:24,000 scale 7 1/2 minute topographic quadrangles Dillard, Ga-NC, Hightower Bald, Ga-NC, and Macedonia, Ga-NC, (modified for USDA Forest Service use).

Where actual field survey bearings and distances were not available, courses were digitized from the Georgia State Plane Coordinate System, West Zone from the above named quads and therefore should be considered approximate. Survey bearings are based on True North and digitized bearings are based on Grid North.

### "EAST PORTION"

THE POINT OF BEGINNING and Point #1E, a point on the Georgia-North Carolina State Line where the Common County Line between Clay County, North Carolina and Macon County, North Carolina intersects the State line;

Thence in a southerly direction approximately 7,397 feet along the meanders on Grassy Ridge, over the high point of elevation 4,406 feet Mean Sea Level (M.S.L.) to Point #2E, a high point above Patterson Gap;

Thence in a southwesterly direction approximately 2,554 feet down the side of the ridge to Point #3E, a point on or near the 3000 foot Contour Line (M.S.L.);

Thence in a northerly, westerly, southwesterly, and then northwesterly direction approximately 8,640 feet along the 3000 foot Contour Line (M.S.L.) to Point #4E, a point in the middle of a south flowing drain, just west of Persimmon Creek;

Thence in a northwesterly direction approximately 606 feet to Point #5E, a point in a low gap;

Thence continuing in a northwesterly direction approximately 1,589 feet down a side drain, across a major drain, and over a low ridge to Point #6E, a point on Coleman River, approximately 1,500 feet south of the confluence of Ridgepole Creek;

Thence in a southwesterly then northwesterly direction approximately 6,759 feet around the base of a knob and the edge of the flood plain, staying north of a drain until crossing the Coleman River Road, then following the drain to Point #7E, a point on Steel Trap Knob;

Thence in a southwesterly direction approximately 9,258 feet along Pot Gap Ridge to Point #8E, a point on the Rabun-Towns County Line;

Thence in a northerly direction approximately 10,013 feet along said County Line to Point #9E, a point at the intersection of said County Line and the Georgia-North Carolina State Line;

Thence in an easterly direction approximately 19,944 feet along the Georgia-North Carolina State Line to THE POINT OF BEGINNING.

The EAST PORTION of the Southern Nantahala Wilderness on the Chattahoochee National Forest containing in aggregate 3,371 Acres more or less.

"WEST PORTION"

The digitized Tie line between the East Portion and West Portion is as follows: Commencing at Point #9E of the East Portion, a point on the Georgia-North Carolina State Line;

Thence S 88°55'W, 1,914 feet along said State Line to Monument #2253;

Thence S 89°14'W, 173 feet along said State Line to Point #27 (NC), a point 50 feet east of the Centerline of Tallulah River Road, also a point on the "North Carolina Portion";

Thence S 89°14'W, 302 feet along said State Line to a point on the east bank of the Tallulah River and Point #24 (NC) of the "North Carolina Portion";

Thence S 89°14'W, 3,125 feet along State Line to THE POINT OF BEGINNING and Point #1W, a point which is Corner 5 of U.S. Tract #N-1074;

Thence in a southeasterly direction 5,364 feet along the boundary of U.S. Tract #N-1074 to Point #2W, a point which is Corner 2a of U.S. Tract #N-1074 and being Corner 6 of U.S. Tract #C-787K;

Thence in a southerly direction along the eastern boundary of U.S. Tract #C-787K 1,236 feet to Point #3W, a point which is Corner 7 of U.S. Tract #787K and being Corner 10 of U.S. Tract #C-1641h;

Thence in a southeasterly and southwesterly direction along the eastern boundary of U.S. Tract #C-1641h 3,944 feet to Point #4W, a point which is Corner 5 of U.S. Tract #C-1641h;

Thence in a westerly direction approximately 7,956 feet up and along a ridge and passing over Newt Knob and on to Point #5W, a point which is a high point on the end of the ridge;

Thence in a southwesterly direction approximately 1,408 feet down a side ridge to Point #6W, a point in the centerline of Charlies Creek;

Thence in a southeasterly direction approximately 979 feet down the centerline of Charlies Creek to Point #7W, a point in the centerline of Charlies Creek;

Thence in a southwesterly direction approximately 1,547 feet up a side drain to Point #8W, a point on or near the 3000 foot contour line (M.S.L.);

Thence in an easterly and then a southwesterly direction approximately 9,638 feet along the meanders of the 3000 foot contour line (M.S.L.) to Point #9W, a point 66 feet north of the centerline of the Blue Ridge Gap Road;

Thence continuing in a southwesterly direction approximately 578 feet along a line 66 feet north of and parallel to the centerline of Blue Ridge Road to Point #10W, a point on Blue Ridge Gap;

Thence continuing in a westerly direction approximately 1,694 feet along a line 66 feet north of and parallel to the centerline of Blue Ridge Road to Point #11W, a point which is Corner 7 of U.S. Tract #C-1716, also being on Land Lot Line between Lots 71 and 72 District 1;

Thence in a northerly direction approximately 3,601 feet along Land Lot Line between Lots 71 and 72, District 1, to Point #12W, a point which is Corner 6 of U.S. Tract #C-1059;

Thence in a westerly direction approximately 1,311 feet along Land Lot Line between Lots 90 and 71, District 1, to Point #13W, a point at the toe of a ridge just across Hightower Creek;

Thence in a northwesterly direction approximately 1,528 feet up the ridge to Point #14W, a point on or near the 3000 foot contour line;

Thence in a westerly and southwesterly direction approximately 12,382 feet along the 3000 foot contour line to Point #15W, a point where the 3000 foot contour line intersects the boundary between Corners 3 and 4 of U.S. Tract #C-1121;

Thence in a northerly direction approximately 389 feet along the boundary to Point #16W, a point which is Corner 4 of U.S. Tract #C-1121;

Thence in a westerly direction 1,299 feet along Land Lot Line between Lots 55 and 60, District 18, Section 1, to Point #17W, a point which is Corner 3 of U.S. Tract #K-94r;

Thence in a southerly direction 2,598 feet along tract boundary to Point #18W, a point which is Corner 4 of U.S. Tract #K-94r;

Thence in a westerly direction 2,202 feet along Land Lot Lines between Lots 60 and 93, and on between Lots 61 and 92 to Point #19W, a point which is Corner 9 of U.S. Tract #C-57Ad;

Thence in a northerly direction 2,651 feet along tract boundary to Point #20W, a point which is Corner 10 of U.S. Tract #C-57Ad;

Thence in a westerly direction 1,674 feet along tract boundary to Point #21W, a point which is Corner 11 of U.S. Tract #C-57Ad;

Thence in a southerly direction 2,598 feet along tract boundary to Point #22W, a point which is the common corner for Land Lots 61, 62, 91 and 92, District 18;

Thence in a southeasterly direction 1,299 feet along tract boundary to Point #23W, a point which is Corner 12 of U.S. Tract #C-57Ad;

Thence in a southwesterly direction 1,800 feet along tract boundary passing in line Corner 13 and on to Point #24W, a point which is Corner 14 of U.S. Tract #C-57Ad;

Thence in a southeasterly direction 602 feet along tract boundary to Point #25W, a point which is Corner 15 of U.S. Tract #C-57Ad;

Thence in a westerly direction 1,848 feet along tract boundary to Point #26W, a point which is Corner 16 of U.S. Tract #C-57Ad;

Thence in a southwesterly direction 2,798 feet along tract boundary to Point #27W, a point which is Corner 17 of U.S. Tract #C-57Ad;

Thence continuing along the tract boundary in a westerly and northerly direction 4,150 feet to Point #28W, a point which is Corner 18 of U.S. Tract #C-57Ad;

Thence in a westerly direction 1,299 feet along the south boundary of U.S. Tract #C-1552 to Point #29W, a point which is a common Land Lot Corner for Lots 89, 90, 101 and 102, District 18;

Thence in a northerly direction 1,500 feet along Land Lot Line between Lots 89 and 90, District 18, to Point #30W, a point which is Corner 25 of U.S. Tract #C-57Ad;

Thence in a southwesterly direction approximately 555 feet along the boundary of U.S. Tract #C-57Ad to Point #31W, a point where the tract boundary intersects on or near the 2,600 foot contour line;

Thence in a northwesterly and then a southerly direction approximately 14,523 feet along the 2,600 foot contour line to Point #32W, a point where the 2,600 foot contour intersects the Land Lot Line between Lots 65 and 88, District 18;

Thence in a westerly direction approximately 978 feet along Land Lot Line between Lots 65 and 88, District 18, to Point #33W, a point which is a common corner for Land Lots 65, 66, 87 and 88, District 18, and also Class "A" Corner #414;

Thence in a northwesterly direction approximately 3,459 feet up a ridge to Point #34W, a point on top of Eagle Mountain which has an elevation of 4,259 feet (M.S.L.);

Thence in a northerly direction approximately 1,955 feet along the crest of Eagle Mountain to Point #35W, a high point near the north end of Eagle Mountain;

Thence in a northwesterly direction approximately 3,767 feet down along Jump Off Ridge to Point #36W, a point on the boundary between Corners 6 and 7 of U.S. Tract #C-1097;

Thence in a northerly direction approximately 2,007 feet along the tract boundary to Point #37W, a point which is Corner 7 of U.S. Tract #C-1097;

Thence in an easterly direction 121 feet along tract boundary to Point #38W, a point which is Corner 8 of U.S. Tract #C-1097;

Thence in a northerly direction 1,452 feet along tract boundary to Point #39W, a point which is Corner 9 of U.S. Tract #C-1097;

Thence in an easterly direction approximately 1,340 feet along tract boundary passing in line Corner 10 and on to Point #40W, a point which is Corner 11 of U.S. Tract #C-1097;

Thence in a northerly direction 1,151 feet along tract boundary to Point #41W, a point which is Corner 12 of U.S. Tract #C-1097 and also on the Georgia-North Carolina State Line;

Thence in an easterly direction 22,630 feet along the Georgia-North Carolina State Line to Point #42W, a point known as "Montgomery Corner" on Sharp Top Ridge and on the Georgia-North Carolina State Line;

Thence in a northerly direction 2,001 feet along the Georgia-North Carolina State Line to Point #43W, a point known as "30 Mile Post";

Thence in an easterly direction approximately 8,342 feet along the Georgia-North Carolina State Line to Point #43A-W, a point where the Wilderness Boundary continues northerly into the "North Carolina Portion" and which also is Point #23 (NC) on "North Carolina Portion";

Thence continuing in an easterly direction approximately 7,311 feet along the Georgia-North Carolina State Line to THE POINT OF BEGINNING.

The Boundary is delineated on a map scale of (2) inches = 1 Mile or 1:31,680 reduced from North Carolina and Georgia U.S.G.S. 1:24,000 scale 7 1/2 minute topographic quadrangles Prentiss, N.C., Rainbow Springs, N.C., Dillard, Ga.-N.C., Hightower Bald, Ga.-N.C., (Modified for USDA Forest Service use). Where actual field survey bearings and distances were not available, courses were digitized from the North Carolina State Plane Coordinate System from the above named quads and therefore should be considered approximate. Survey bearings are based on True North and digitized bearings are based on Grid North.

THE POINT OF BEGINNING and Point #1 (NC), a point which is Corner 6 of U.S. Tract #N-354b and also Class "A" Monument #2139 on the North Carolina-Georgia State Line;

Thence in a northerly and northeasterly direction along the tract boundaries of U.S. Tracts #N-354b and #N-170 with the following (11) courses:

Thence in a northwesterly direction approximately 5,539 feet along the crest of Brushy Ridge to Point #2A (NC), a point where the crest of Brushy Ridge intersects the Coweeta Hydrologic Laboratory Boundary near Pickens Nose;

Thence in a northwesterly direction approximately 4,053 feet continuing along the crest of Brushy Ridge and the Coweeta Hydrologic Laboratory Boundary to Point #3 (NC), a point 100 feet south of the centerline of Forest Service Road 83 and Grassy Gap on top of the divide between Ball Creek and Betty Creek;

Thence in a northwesterly direction approximately 3,888 feet along a line 100 feet south of and parallel to the centerline of Forest Service Road 83 to Point #4 (NC), a point 100 feet west of the intersection of the Appalachian Trail and said road;

Thence leaving said road along a line 100 feet northwesterly of and approximately parallel to the center of the Appalachian Trail with the following (134) digitized courses:

to Point #5 (NC), a point 100 feet northwesterly of the Appalachian Trail and near the intersection of Scream Ridge and Little Ridgepole Mountain;

Thence leaving the Appalachian Trail and traversing in a northwesterly direction approximately 9,894 feet with the meanders of the west prong of Scream Ridge paralleling Big Laurel Branch and down the ridge to Point #6 (NC), a point at the intersection of Big Laurel Branch and Mooney Creek;

Thence in a westerly direction approximately 1,518 feet up a spur ridge to Point #7 (NC), a point on the west edge of Big Indian Loop Trail;

Thence in a southwesterly direction approximately 1,727 feet along the west edge of the Big Indian Loop Trail to Point #8 (NC), a point on the west edge of Big Indian Loop Trail and also in Kilby Gap that intersects a spur ridge on Blue Ridge;

Thence in a westerly direction approximately 568 feet along the meanders of said ridgeline to Point #9 (NC), a point where said ridgeline intersects the 4400 foot contour line;

Thence in a northwesterly direction approximately 26,149 feet along the meanders of the 4400 foot contour line to Point #10 (NC), a point in the center of an unnamed drain east of an unnamed knob north of Frog Mountain;

Thence in a northeasterly direction approximately 261 feet along the center of the drain down to Point #11 (NC), a point in the center of the drain that intersects the 4200 foot contour line;

Thence in a northwesterly and then in a southwesterly direction approximately 18,812 feet along the meanders of the 4200 foot contour line to Point #12 (NC), a point where the 4200 foot contour line intersects the centerline of Chestnut Ridge;

Thence in a southerly direction approximately 1,846 feet ascending the meanders of Chestnut Ridge to Point #13 (NC), a point where the centerline of said ridge intersects the 4600 foot contour line;

Thence in a southwesterly direction approximately 3,896 feet along the meanders of the 4600 foot contour line to Point #14 (NC), a point at the intersection of the 4600 foot contour line and the Macon and Clay Counties Line;

Thence in a westerly direction approximately 2,826 feet along the Macon and Clay Counties Line through Deep Gap and up the ridge to Point #15 (NC), a point on the Macon and Clay Counties Line and a high point on the south end of Yellow Mountain, also on the Tennessee Valley Divide;

Thence in a southwesterly direction approximately 1,294 feet along the Tennessee Valley Divide and crossing the Appalachian Trail to Point #16 (NC), a point 100 feet west of said trail at Wateroak Gap;

Thence in a southwesterly direction along a line 100 feet northwesterly of and approximately parallel to the center of the Appalachian Trail with the following (58) digitized courses:


