

**JARBIDGE WILDERNESS ADDITION 1
LEGAL DESCRIPTION**

The area included in the Jarbidge Addition 1 Wilderness is located within the Humboldt National Forest, Intermountain Region and within Elko County, Nevada in accordance with the Nevada Wilderness Protection Act of 1989 (P.L. 101-195). The official boundary description and final maps are on file and available in the offices of the Forest Supervisor, Humboldt-Toiyabe National Forest, Sparks, Nevada and the Regional Forester, Intermountain Region, Ogden, Utah. The Jarbidge Wilderness Addition 1 consists of an area of 1,470 acres, more or less, which was computed from 1:24,000 scale, 7 1/2 minute quadrangle maps using the Forest's Geographic Information System (GIS). A detailed description of the boundary follows:

Beginning at the northeast corner of Section 9, Township 46 North, Range 59 East, Mount Diablo Meridian, - the existing JARBIDGE WILDERNESS BOUNDARY;

thence westerly to a point 200 feet west of and parallel to the centerline of Biroth Ridge Road no. 58285;

thence northwesterly and northerly approximately 1.8 miles descending along said ridge, 200 feet west of and parallel to the centerline of Biroth Ridge Road no. 58285 to the terminus of said road at an approximate elevation 7,400 feet;

thence northerly approximately 2,700 feet along ridge top to an elevation 6,800 feet;

thence northwesterly approximately 1,500 feet to the northwest corner of Section 33, T. 47 N., R. 59 E., MDM;

thence southwesterly approximately 4,600 feet to the bottom of the EAST FORK JARBIDGE RIVER at elevation 6,000 feet;

thence southwesterly approximately 2,200 feet to a point on the north boundary of Section 5, T. 46 N., R. 59 E., MDM, from which the northwest section corner of Section 5 bears westerly, 700 feet;

thence S 30° W approximately 1,700 feet to the west boundary of said Section 5;

thence southerly along the west boundary of said Section 5 to the northwest corner of Section 8, T. 46 N., R. 59 E., MDM - the existing JARBIDGE WILDERNESS BOUNDARY.

**JARBIDGE WILDERNESS
ADDITION 2
LEGAL DESCRIPTION**

The area included in the Jarbidge Wilderness Addition 2 is located within the Humboldt National Forest, Intermountain Region and within Elko County, Nevada in accordance with the Nevada Wilderness Protection Act of 1989 (P.L. 101-195). The official boundary description and final maps are on file and available in the offices of the Forest Supervisor, Humboldt-Toiyabe National Forest, Sparks, Nevada and the Regional Forester, Intermountain Region, Ogden, Utah. The Jarbidge Wilderness Addition 2 consists of an area of 18,670 acres, more or less, which was computed from 1:24,000 scale, 7 1/2 minute quadrangle maps using the Automated Lands Program Geographic Information System (GIS). A detailed description of the boundary follows:

Beginning at a point 50 feet west of the centerline of Humming Bird Spring Trail no. 099 on the south boundary of Section 36, Township 46 North, Range 59 East, Mount Diablo Meridian, - on the existing JARBIDGE WILDERNESS BOUNDARY, said point being approximately 200 feet west of the southeast corner of said Section 36;

thence southeasterly approximately 1,400 feet, 50 feet westerly from and parallel to the centerline of said Trail no. 099 to an intersection with a trail into CANYON CREEK at approximate elevation 9,220 feet;

thence approximately S 64° E, 900 feet to the top of a knob at elevation 9,250 feet;

thence northerly approximately 2,000 feet along a ridge top to elevation 9,080 feet;

thence approximately N 50° E, 4,400 feet to the top of a knob at elevation 8,870 feet;

thence N 37° E approximately 1,600 feet to elevation 8,400 feet;

thence northeasterly approximately 1.8 miles along elevation 8,400 feet to a ridge in the SE1/4, Section 20, T. 46 N., R. 60 E., MDM;

thence descending said ridge southeasterly approximately 800 feet to elevation 8,200 feet;

thence northerly approximately 1.7 miles along elevation 8,200 feet to a ridge top in the NE1/4, Section 21, T. 46 N., R. 60 E., MDM;

thence approximately N 40° E, 1,200 feet to the northeast corner of said Section 21;

thence easterly along the north boundary of Section 22, T. 46 N., R. 60 E., MDM, approximately 1,700 feet to elevation 8,000 feet;

thence northwesterly approximately 1,000 feet along elevation 8,000 feet to the bottom of a draw;

thence descending easterly approximately 1,200 feet along the bottom of said draw to elevation 7,800 feet;

thence approximately S 35° E, 2,400 feet to the top of a knob at approximate elevation 7,760 feet;

thence S 67° E, approximately 1,700 feet to the east boundary of Section 22, T. 46 N., R. 60 E., MDM;

thence south approximately 1.5 miles, along the east boundary of Sections 22 and 27 to a point being 100 feet NORTH from the centerline of Road no. 58074B;

thence westerly and northwesterly approximately 1.8 miles, 100 feet northerly from and parallel with the centerline of Road no. 58074B to it's terminus at approximate elevation 7,660 feet;

thence southeasterly and easterly approximately 1.8 miles, around the terminus of said road, a radius of 100 feet, 100 feet southerly from and parallel with the centerline of said road, to the east boundary of Section 27, T. 46 N., R. 60 E., MDM;

thence approximately S 47° W, 2,800 feet to the top of a knob at approximate elevation 7,600 feet;

thence approximately S 27° W, 3,800 feet crossing SOUTH FORK CANYON CREEK to the top of a knob at elevation 7,740 feet;

thence approximately S 23° E, 1.1 miles to the top of a knob at approximate elevation 7,140 feet;

thence westerly approximate 2,300 feet to the bottom of GOAT CREEK at elevation 6,800 feet;

thence approximately S 30° E, 2,200 feet to the top of a knob at elevation 7,250 feet;

thence approximately S 3° E, 2,100 feet to the top of a ridge at elevation 7,060 feet, near the north boundary of Section 15, T. 45 N., R. 60 E., MDM;

thence approximately S 43° W, 2,300 feet to the top of a ridge at an elevation 7,000 feet;

thence southwesterly approximately 1,300 feet crossing NORTH FORK COTTONWOOD CREEK, to a knob with an approximate elevation of 6,880 feet;

thence southwesterly approximately 1,200 feet to a knob with an approximate elevation of 7,000 feet;

thence N 50° W, 3,500 feet, to a ridge top at approximately elevation 7,360 feet;

thence N 60° W, 1,500 feet, to a ridge top at approximately elevation 7,520 feet;

thence northwesterly approximately 1,500 feet to the top of a ridge at elevation 7,800 feet;

thence approximately S 10° W, 700 feet to the southwest corner of said Section 9, T. 45 N., R. 60 E., MDM;

thence southerly approximately 200 feet to a point 200 feet west of the terminus of Road no. 58317C;

thence southeasterly and easterly approximately 1.4 miles, 400 feet southerly from and parallel with the centerline of said road to an elevation 7,000 feet, said point being near the west section of Section 15, T. 45 N., R. 60 E., MDM ;

thence southeasterly along a ridge approximately 700 feet to the southwest corner of said Section 15;

thence southerly approximately 300 feet to the top of a knob at approximate elevation 7,040 feet;

thence southerly approximately 2,000 feet to the bottom of MIDDLE FORK COTTONWOOD CREEK, and at the confluence with an unnamed drainage from the west at elevation 6,660 feet;

thence ascending westerly approximately 2,800 feet, along the bottom of said unnamed drainage to elevation 6,920 feet;

thence approximately S 50° W, 1,100 feet to the top of a knob at elevation 7,300 feet;

thence approximately S 13° W, 2,700 feet to a ridge top at elevation 7,000 feet, near the north boundary of Section 28, T. 45 N., R. 60 E., MDM;

thence westerly approximately 2,000 feet, along the top of a ridge to the top of a knob at approximate elevation 7,500 feet;

thence approximately S 24° W, 3,100 feet to the top of a knob at approximate elevation 7,400 feet;

thence approximately S 20° W, 1.1 miles to the top of a knob at elevation 7,334 feet;

thence descending southeasterly and southerly approximately 1,800 feet, along the bottom of a draw, to a point at elevation 6,600 feet;

thence southwesterly approximately 800 feet to a point in Cottonwood Creek, said point being 100 feet northwesterly of and parallel to Road no. 58319;

thence S 30° W, approximately 200 feet to a point on the north boundary of Section 5, T. 44 N., R. 60 E., MDM;

thence westerly approximately 1.5 miles, along the north boundary of Sections 5 and 6, to the northwest corner of Section 6, T. 44 N., R. 60 E., MDM;

thence southerly approximately 1.5 miles, along the west boundary of Sections 6 and 7, to the top of a ridge near the west 1/4 corner of Section 7, T. 44 N., R. 60 E., MDM, at approximate elevation 6,960 feet;

thence approximately S 74° W, 3,200 feet to the top of a ridge at elevation 7,200 feet;

thence northwesterly approximately 4,900 feet along a ridge top to the top of a knob at elevation 8,424 feet;

thence approximately S 49° W, 3,700 feet to the top of a knob at elevation 8,701 feet;

thence approximately N 40° W, 1,100 feet to the 1/4 corner common to Sections 10 and 11, T. 44 N., R. 59 E., MDM - the existing JARBIDGE WILDERNESS BOUNDARY.

**JARBIDGE WILDERNESS
ADDITION 3
LEGAL DESCRIPTION**

The area included in the Jarbidge Wilderness Addition 3 is located within the Humboldt National Forest, Intermountain Region and within Elko County, Nevada in accordance with the Nevada Wilderness Protection Act of 1989 (P.L. 101-195). The official boundary description and final maps are on file and available in the offices of the Forest Supervisor, Humboldt-Toiyabe National Forest, Sparks, Nevada and the Regional Forester, Intermountain Region, Ogden, Utah. The Jarbidge Wilderness Addition 3 consists of an area of 26,280 acres, more or less, which was computed from 1:24,000 scale, 7 1/2 minute quadrangle maps using the Forest's Geographic Information System (GIS). A detailed description of the boundary follows:

Beginning on the existing JARBIDGE WILDERNESS BOUNDARY at the township corner of Townships 43 and 44 North, Range 58 and 59 East, Mount Diablo Meridian;

thence southerly approximately 0.5 miles along the east boundary of Section 1 to the east 1/4 corner of Section 1, T. 43 N., R. 58 E., MDM;

thence westerly approximately 1.0 mile, along the east-west centerline of said Section 1, to the west 1/4 corner of said Section 1;

thence approximately N 87° W, 2,700 feet, crossing WILLIAMS BASIN CREEK to the top of a ridge at elevation 7,000 feet;

thence N 30° W approximately 3,300 feet to the north boundary of Section 2, T. 43 N., R. 58 E., MDM, on the existing JARBIDGE WILDERNESS BOUNDARY;

thence westerly along the north boundary to the northwest corner of said Section 2;

thence SOUTH approximately 200 feet to elevation 6,600 feet;

thence southerly approximately 1.2 miles along elevation 6,600 feet to a minor draw near the south boundary of said Section 2;

thence southwesterly approximately 1,800 feet to the bottom of SHORT CREEK at elevation 6,400 feet;

thence southerly approximately 3,300 feet to an unnamed drainage at elevation 6,360 feet near the south boundary of Section 11, T. 43 N., R. 58 E., MDM;

thence SOUTH approximately 300 feet to an elevation of 6,400 feet;

thence southerly approximately 1.3 miles along elevation 6,400 feet to a point near the south 1/4 corner of Section 14, T. 43 N., R. 58 E., MDM;

thence approximately N 85° W, 1.0 mile to Triangulation Station "BOUNDARY" at elevation 7,501 feet;

thence approximately N 30° W, 4,400 feet to the centerline of a Trail no. 014 in the bottom of LITTLE RESERVOIR BASIN at elevation 6,960 feet;

thence approximately S 84° W, 2,500 feet to the top of a knob at elevation 7,292 feet;

thence approximately S 35° W, 3,000 feet to the top of a knob at elevation 7,114 feet;

thence approximately S 56° W, 2,300 feet to the southeast corner of Section 17, T. 43 N., R. 58 E., MDM;

thence westerly approximately 2.0 miles, along the south boundary of Sections 17 and 18, crossing EAST FORK WILLOW CREEK, to the southwest corner of Section 18, T. 43 N., R. 58 E., MDM;

thence northerly approximately 1.0 mile along the west boundary of said Section 18, crossing WILLOW CREEK, to the northwest corner of said Section 18;

thence approximately N 30° W, 1.0 mile, crossing PERSON CREEK, to the west edge of a ridge top at elevation 6,800 feet;

thence approximately N 3° E, 1.4 miles to the top of a knob at elevation 7,321 feet;

thence approximately N 32° E, 1.4 miles, crossing WADDY CREEK, to the top of a knob at elevation 7,902 feet;

thence approximately N 13° E, 3,000 feet to the top of a knob at elevation 7,900 feet;

thence approximately N 24° E, 2,400 feet to the top of a knob at elevation 7,990 feet;

thence approximately N 50° E, 1,500 feet to the top of a knob at approximate elevation 7,850 feet;

thence approximately N 3° E, 1.4 miles, crossing SEVENTYSIX CREEK, to the top of a peak at elevation 7,630 feet;

thence northerly and northeasterly approximately 3,500 feet along a ridge top to a saddle near a benchmark monument at elevation 7,077 feet, in the NE ¼ of Section 7, T. 44 N., R. 58 E., MDM;

thence continuing northeasterly approximately 4,000 feet along said ridge top to the top of a knob at elevation 7,668 feet;

thence approximately N 19° E, 1.5 miles to a point which is EAST, 200 feet from the CAMP DRAW TRAILHEAD;

thence approximately N 15° W, 300 feet to the intersection of two forks of SEVENTYSIX CREEK;

thence ascending northwesterly approximately 3,000 feet along the bottom of SEVENTYSIX CREEK to elevation 8,000 feet;

thence approximately N 71° W, 1,600 feet to the top of a peak at approximate elevation 8,700 feet;

thence northerly approximately 4.2 miles along the top of the drainage divide between COON CREEK and the JARBIDGE RIVER - the Ranger District boundary - crossing COON CREEK PEAK, to the top of a peak at elevation 9,020 feet;

thence northeasterly approximately 0.5 miles along a ridge top to a point 600 feet southerly of the centerline of the Road no. 58752 in BEAR CREEK in the SE¼ of Section 31, T. 46 N., R. 58 E., MDM;

thence northeasterly approximately 2.3 miles, 600 feet easterly of and parallel to the centerline of the Road no. 58752 in BEAR CREEK to a point 600 feet southerly from said road on the ridge between BEAR CREEK and the JARBIDGE RIVER;

thence southeasterly approximately 4,500 feet, 600 feet westerly of and parallel to the centerline of the Road no. 58752 to a point perpendicular and west of the junction of the said road and Road no. 58064;

thence southeasterly approximately 2 miles, 600 feet westerly from and parallel with the centerline of the Road no. 58064 in JARBIDGE RIVER CANYON to a ridge near the north boundary of Section 10, T. 45 N., R. 58 E., MDM, with an approximate elevation of 7,240 feet;

thence southeasterly approximately 1,700 feet to the bottom of JARBIDGE RIVER at elevation 7,000 feet;

thence approximately N 11° W, 1,700 feet to a ridge top north of SNOWSLIDE GULCH at elevation 7,280 feet;

thence ascending northeasterly approximately 1.5 miles along a ridge top to the top of JUMBO PEAK - the existing JARBIDGE WILDERNESS BOUNDARY.

Qualifications:

The boundary narrative for the Jarbidge Wilderness Additions are based on the 7 1/2 minute Quadrangle Maps listed below. This legal description has been plotted on the USDA Forest Service Primary Base Series Maps which are reduced to 1-inch-equals-1 mile. These maps are attached and made part of the description. All references to elevation in this description are based on the National Geodetic Vertical Datum of 1929.
