BOUNDARY DESCRIPTION

WILD ROGUE WILDERNESS

The Wild Rogue Wilderness consists of an area of approximately 35,960.29 acres in the State of Oregon, referenced to the Willamette Meridian, centered about T. 33 S., R. 10 W., and described as follows:
