

UPLAND ISLAND WILDERNESS BOUNDARY DESCRIPTION

1986 AMENDMENTS

The Upland Island Wilderness Boundary Amendments are located on the Angelina National Forest, Angelina Ranger District, Angelina and Jasper Counties, Texas, bounded generally on the north by Angelina County Road No. 4-4, on the east by Forest Development Road No. 303, on the south by the Neches River, and on the west by U.S. Highway No. 69.

The Wilderness Boundary Amendments are delineated on U.S.G.S. 1:24,000 scale 7 1/2 minute topographic quadrangles Boykin Springs, Cassells-Boykin Park, Rockland and Zavalla (modified for USDA Forest Service use). Where actual field survey bearings and distances were not available, courses were digitized from the Texas State Plane Coordinate System, Central Zone, using the above named quadrangles and therefore should be considered to be approximate. Survey bearings are based on True North and digitized bearings are based on Grid North.

1986 Amendments to the Wilderness Boundary by Public Law 99-584, October 29, 1986

(NORTH AREA)

AREA "A"

Commencing at Corner 40 of USA Tract #Ala-I, a Forest Service standard concrete post marked "A-88", witnessed by scribed bearing trees. Thence N 00° 10'W, 1,545.06 feet (deed) to Corner 41 of USA Tract #Ala-I, a stake with witnesses and being Point #NA1, THE POINT OF BEGINNING OF AREA "A";

Thence S 89° 15'W (deed), 1,438 feet (digitized) along the boundary of USA Tract #Ala-I to Point #NA2, a point where the tract boundary between corners 41 and 42 intersects with a line 33 feet easterly of and parallel to the centerline of Forest Development Road No. 330;

Thence in a northwesterly and then in a northeasterly direction along a line offset 33 feet easterly of and parallel to the centerline of FDR No. 330 approximately 2,814 feet (digitized) to Point #NA3, a point at the intersection of said offset line and the boundary of USA Tract #Ala-I between corners 34 and 35;

Thence along the boundary of USA Tract #Ala-I the following courses:

1. S 01°20'E (deed), 758 feet (digitized) to corner 35;
2. N 89°10'E, 1,254.66 feet (deed) to corner 36;
3. North, 117.48 feet (deed) to corner 37;
4. N 89°05'E, 2,396.46 feet (deed) to corner 38;
5. S 00°10'E (deed), 1,718 feet (digitized) to Point #NA4, a point on the boundary of USA Tract #Ala-I between corners 38 and 39;

Thence leaving #Ala-I boundary along a line West, 2,364 feet (digitized) to Point #NA5, a point on the boundary of USA Tract #Ala-I between corners 40 and 41;

Thence N 00°10'W (deed), 251 feet (digitized) along the boundary of USA Tract #Ala-I to Point #NA1, THE POINT OF BEGINNING.

The Area "A" addition to Upland Island Wilderness contains 157 Acres more or less as digitized from the above named quadrangle maps.

AREA "F"

THE POINT OF BEGINNING and Point #NF1, a point identical with Point # N15 of original wilderness boundary and at the intersection of a line 33 feet northerly of and parallel to the centerline of Forest Development Road No. 314 and a line 100 feet east of and parallel to the east right-of-way line of the Texas and New Orleans Railroad;

Thence in a westerly direction 100 feet (digitized) along a line offset 33 feet northerly of and parallel to the centerline of FDR No. 314 to Point #NF2, a point at the intersection of said 33 foot offset line and the east right-of-way line of the Texas and New Orleans Railroad;

Thence in a northwesterly direction along the east right-of-way line of the Texas and New Orleans Railroad approximately 4,573 feet (digitized) to Point #NF3, a point at the intersection of said right-of-way line and the boundary of USA Tract #Ala-I between corners 2 and 3;

Thence N 89°20'E (deed), 114 feet (digitized) along the boundary of USA Tract #Ala-I between corners 2 and 3 to Point #NF4, a point at the intersection of said tract boundary and a line 100 feet easterly of and parallel to the east right-of-way line of the Texas and New Orleans Railroad, and identical with Point # N16 of the Original Wilderness Boundary;

Thence in a southeasterly direction along a line 100 feet east of and parallel to the east right-of-way line of the Texas and New Orleans Railroad approximately 4,558 feet (digitized) to Point #NF1, THE POINT OF BEGINNING.

The Area "F" addition to the Upland Island Wilderness contains 10 acres more or less as digitized from the above named quadrangle maps.

AREA "G"

1986 Exception from Wilderness Area

THE POINT OF BEGINNING and Point #NG1, a point which is corner 1 of USA Tract #A-26, and also Point #N26 of Original Wilderness Boundary;

Thence along the boundary of USA Tract #A-26 the following deed courses:

1. N $89^{\circ}04'14''$ W, 265.78 feet to corner 5, also Point #NG2;
2. S $87^{\circ}42'12''$ W, 400.17 feet to corner 4, also Point #NG3;
3. N $00^{\circ}57'50''$ W, 1,083.02 feet to corner 3, also Point #NG4;
4. N $89^{\circ}34'E$, 655.67 feet to corner 2, also Point #NG5 and Point #N27 on Original Wilderness Boundary;
5. S $01^{\circ}30'E$, 1,076.47 feet to corner 1 and Point #NG1, THE POINT OF BEGINNING.

The Area "G" 1986 Exception from the Upland Island Wilderness contains 16 Acres more or less as from deed records.

AREA "H"

THE POINT OF BEGINNING and Point #NH1, a point at the intersection of a line 33 feet northeasterly of and parallel to the centerline of Angelina County Road No. 4-5 and the boundary of USA Tract #Ala-I between corners 5 and 6, identical with point #N16a of Original Wilderness Boundary;

Thence along boundary of USA Tract #Ala-I the following courses:

1. N $01^{\circ}00'W$ (deed), 268.52 feet (digitized) to corner 6, which is Point #NH2;
2. S $89^{\circ}00'W$ (deed), 472 feet (digitized) between corners 6 and 7 to Point #NH3, a point at the intersection of said tract boundary and a line 33 feet northeasterly of and parallel to the centerline of Angelina County 4-5, and also Point #(N17) of Original Wilderness Boundary;

Thence in a southeasterly direction along a line 33 feet northeasterly of and parallel to the centerline of Angelina County Road No. 4-5 approximately 543 feet (digitized) to Point #NH1, THE POINT OF BEGINNING.

The Area "H" addition to Upland Island Wilderness contains 1 Acre more or less as digitized from the above named quadrangle maps.

SOUTH AREA

AREA "B"

1986 Exception from Wilderness Area

THE POINT OF BEGINNING and Point #SB1, a point at the intersection of the line 33 feet westerly and southerly of and parallel to the centerline of Jasper County Road No. 8, and a line 33 feet southwesterly of and parallel to the centerline of an old dirt road that runs in a southeasterly direction to private land and identical with point #S2 of Original Wilderness Boundary;

Thence in an easterly direction along the line 33 feet southerly of and parallel to the centerline of Jasper County Road No. 8 approximately 1,917 feet (digitized) to Point #SB2, a point at the intersection of said 33 foot offset line with the boundary of USA Tract #Ala-I between corners 49 and 50, being Point #S3 of the Original Wilderness Boundary;

Thence West (deed) 1,479.97 feet (digitized) along boundary of USA Tract Ala-I to Point #SB3, a point at the intersection of said tract boundary and a line 33 feet southwesterly of and parallel to the centerline of an old dirt road that runs in a southeasterly direction to private land, and also Point #S4 of Original Wilderness Boundary;

Thence in a northwesterly direction 534 feet (digitized) along a line 33 feet southwesterly of and parallel to the centerline of said road to Point #SB1, THE POINT OF BEGINNING.

The Area "B" 1986 Exception from the Upland Island Wilderness contains 6 Acres more or less as digitized from the above named quadrangle maps.

AREA "C"

THE POINT OF BEGINNING and Point #SC1, a point at the intersection of the north bank of the Neches River and a line 100 feet east of and parallel to the east right-of-way line of the Texas and New Orleans Railroad, and also Point #S8 of the Original Wilderness Boundary;

Thence in a northwesterly direction along the north bank of the Neches River approximately 117 feet (digitized) to Point #SC2, a point at the intersection of the north bank of the Neches River and the east right-of-way line of the Texas and New Orleans Railroad;

Thence in a northwesterly direction along the east right-of-way line of the Texas and New Orleans Railroad approximately 4,281 feet (digitized) to Point #SC3, a point at the intersection of said east right-of-way line and the boundary of USA Tract #Ala-I between corners 56 and 57;

Thence N 01°30'W (deed), 191 feet (digitized) along the boundary of USA Tract #Ala-I to Point #SC4, a point at the intersection of said tract boundary and a line 100 feet east of and parallel to the east right-of-way line of the Texas and New Orleans Railroad, and also Point #S9 of Original Wilderness Boundary;

Thence in a southeasterly direction along said line approximately 4,543 feet (digitized) to Point #SC1, THE POINT OF BEGINNING.

The Area "C" Addition to Upland Island Wilderness contains 10 Acres more or less as digitized from the above named quadrangle maps.

AREA "E"

THE POINT OF BEGINNING and Point #SE1, a point at the intersection of a line 100 feet east of and parallel to the east right-of-way line of the Texas and New Orleans Railroad and the boundary of USA Tract #Ala-I between corners 1 and 57, and also Point #S10 of Original Wilderness Boundary;

Thence S 89°33'W (deed), 103 feet (digitized) along the boundary of USA Tract #Ala-I to Point #SE2, a point at the intersection of said tract boundary and the east right-of-way line of the Texas and New Orleans Railroad;

Thence in a northwesterly direction 1,136 feet (digitized) along the east right-of-way line of the Texas and New Orleans Railroad to Point #SE3, a point at the intersection of said east right-of-way line and a line 33 feet south of and parallel to the centerline of Forest Development Road No. 314;

Thence in an easterly direction 100 feet (digitized) along the line offset 33 feet south of and parallel to the centerline of Forest Development Road No. 314 to Point #SE4, a point at the intersection of said line and a line 100 feet east of and parallel to the east right-of-way line of the Texas and New Orleans Railroad, and also Point #S11 of Original Wilderness Boundary;

Thence in a southeasterly direction 1,147 feet (digitized) along the line 100 feet east of and parallel to the east right-of-way line of the Texas and New Orleans Railroad to Point #SE1 and THE POINT OF THE BEGINNING.

The Area "E" Addition to Upland Island Wilderness contains 2 Acres more or less as digitized from the above named quadrangle maps.
