


NATIONAL WILDERNESS PRESERVATION SYSTEM

LEGAL DESCRIPTION - HEADWATERS WILDERNESS - NICOLET NATIONAL FOREST - WISCONSIN

The Headwaters Wilderness is located on the Eagle River Ranger District on the Nicolet National Forest, Forest County, Wisconsin. The boundary is delineated on the map made a part of this description and is entitled: Headwaters Wilderness, Act of June 19, 1984, PL-98-321.

Measurements between controlling corner and line positions and reference features on the boundary of Headwaters Wilderness are map scaled measurements subject to change with an accurate legal survey made in compliance with the rules for the survey of the public lands. The legal boundary description of the Headwaters Wilderness is:

Fourth Principal Meridian

PART I

T. 39 N., R. 12 E.

1. Beginning at the section corner common to sections 32 and 33, T. 39 N., R. 12 E., and sections 4 and 5, T. 38 N., R. 12 E.
2. Northerly 0.1 mile along section line between sections 32 and 33 to the intersection with the centerline of Forest Road 2182 and easterly of Forest Road 2176.
3. Northerly to the point of beginning being 100 feet north of the centerline of Forest Road 2182 and 100 feet east of the centerline of Forest Road 2176.
4. Northeasterly 6.3 miles, 100 feet easterly of and parallel to centerline of FR 2176, to 100 feet southerly of the centerline of Forest Road 2177.
5. Southeasterly 2.8 miles, 100 feet southerly of and parallel to the centerline of Forest Road 2177.

T. 39 N., R. 13 E.

6. Southeasterly 1.5 miles, 100 feet southerly of and parallel to the centerline of Forest Road 2177, to 100 feet southerly of the centerline of Forest Road 2174.
7. Southeasterly 1.4 miles, 100 feet southerly of and parallel to the centerline of Forest Road 2174, to 100 feet northerly of the centerline of Forest Road 2182.
8. Southwesterly 1.7 miles, 100 feet northerly of and parallel to the centerline of Forest Road 2182.

T. 39 N., R. 12 E.

9. Southwesterly 4.5 miles, 100 feet northerly of and parallel to the centerline of Forest Road 2182, to 100 feet easterly of centerline of Forest Road 2176, which is the point of beginning.

PART II

T. 39 N., R. 12 E.

10. Beginning at the section corner common to sections 32 and 33, T. 39 N., R. 12 E., and sections 4 and 5, T. 38 N., R. 12 E.
11. Northerly 0.1 mile along section line between sections 32 and 33 to 100 feet southerly of centerline of Forest Road 2182.
12. Northeasterly 2.8 miles, 100 feet southerly of and parallel to centerline of Forest Road 2182, to 100 feet easterly of centerline of Forest Road 2414, which is point of beginning.
13. Northeasterly 1.7 miles, 100 feet southerly of and parallel to centerline of Forest Road 2182.

T. 39 N., R. 13 E.

14. Northeasterly 1.7 miles, 100 feet southerly of and parallel to centerline of Forest Road 2182, to 100 feet westerly of centerline of Forest Road 2174.
15. Southwesterly 2.0 miles, 100 feet westerly of and parallel to centerline of Forest Road 2174.

T. 38 N., R. 13 E.

16. Southwesterly 4.0 miles, 100 feet westerly of and parallel to centerline of Forest Road 2174, to 100 feet northerly of centerline of Forest Road 2183.
17. Northwesterly 0.8 mile, 100 feet northerly of and parallel to centerline of Forest Road 2183.

T. 38 N., R. 12 E.

18. Westerly 1.0 mile, 100 feet northerly of and parallel to centerline of Forest Road 2183, to section line between sections 23 and 24.
19. North 0.6 mile along section line between sections 23 and 24 to section corner common to sections 13, 14, 23 and 24.
20. Westerly 2.0 mile along section line between sections 14 and 23 and section line between sections 15 and 22 to section corner common to sections 15, 16, 21 and 22.

T. 38 N., R. 12 E.

21. Southerly 0.1 mile along section line between sections 21 and 22 to 100 feet northerly of centerline of Forest Road 2183.
22. Northwesterly 1.4 miles, 100 feet northerly of and parallel to centerline of Forest Road 2183, to 100 feet easterly of centerline of Forest Road 2414.
23. Northeasterly 4.3 miles, 100 feet easterly of and parallel to centerline of Forest Road 2414.

T. 39 N., R. 12 E.

24. Northeasterly 0.7 mile, 100 feet easterly of and parallel to centerline of Forest Road 2414, to 100 feet southerly of centerline of Forest Road 2182 which is the point of beginning.

PART III

T. 39 N., R. 12 E.

25. Beginning at the section corner common to sections 32 and 33, T. 39 N., R. 12 E., and sections 4 and 5, T. 38 N., R. 12 E., which is the point of beginning.
26. Northerly 0.1 mile along section line between sections 32 and 33 to 100 feet southerly of centerline of Forest Road 2182.
27. Northeasterly 2.7 miles, 100 feet southerly of and parallel to centerline of Forest Road 2182, to 100 feet westerly of centerline of Forest Road 2414.
28. Southwesterly 0.7 mile, 100 feet westerly of and parallel to centerline of Forest Road 2414.

T. 38 N., R. 12 E.

29. Southwesterly 4.3 miles, 100 feet westerly of and parallel to centerline of Forest Road 2414, to 100 feet northerly of centerline of Forest Road 2183.
30. Northwesterly 0.9 mile, 100 feet northerly of and parallel to centerline of Forest Road 2183, to 100 feet easterly of centerline of Forest Road 3865.
31. Northeasterly 1.7 miles, 100 feet easterly of and parallel to centerline of Forest Road 3865, to section line between sections 5 and 8.
32. Easterly 0.3 mile along section line between sections 5 and 8 to section corner common to sections 4, 5, 8 and 9.
33. Northerly 1.0 mile along section line between sections 4 and 5 to section corner common to sections 4 and 5 of T. 38 N., R. 12 E., and sections 32 and 33 of T. 39 N., R. 12 E., which is the point of beginning.
