Boundary Description, Fitzpatrick Wilderness, Shoshone N.F.

Beginning at the section corner common to Sections 29, 30, 31 and 32
T. 40 N., R. 105 W., 6th P.M.

Thence east to the section corner common to Sections 28, 29, 32, and
33, T. 40 N., R. 105 W.;

Thence south to the section corner common to Sections 4, 5, 8 and
9 T. 39 N., R. 105 W.;

Thence east to the northeast corner of Section 9 T. 39 N., R. 105
W.;

Thence south 27.17 miles on the Forest boundary to the southern tip
of Shoshone National Forest, this being A.P. No. 1 of Section 15,
T. 15 N., R. 6 W. Wind River Meridian and located on the Con-
tinental Divide;

Thence northwesterly 45.86 miles on and following the Continental
Divide, to the summit of Three Waters Mountain;

Thence northerly 6.69 miles on the Continental Divide to a summit
with a shown contour elevation of 11,360 feet and located at
longitude 109°46'24" and latitude 43°26'47";

Thence northerly down the ridge top to its intersection with the
south line of Section 2 T. 40 N., R. 108 W.;

Thence east along the section lines common to Section 2 and Section
11, Section 1 and Section 12, Section 6 and Section 7, T. 40 N.,
R. 107 W., and R. 108 W., to its intersection with the east edge
of the tread of the Whiskey Mountain Trail;

Thence north and northeasterly 2.2 miles along the east and south
edge of the tread of the Whiskey Mountain Trail to its junction
with Jakeys Fork Trail;

Thence 1.92 miles northeasterly along the south edge of the tread of
Jakeys Fork Trail to its intersection with the top of a ridge
running southeasterly through the SW $\frac{1}{4}$ of Section 27;

Thence 0.3 mile southeasterly on top of ridge to a summit with a
shown contour elevation of 9880 feet;

Thence 1.1 miles northeasterly in a straight line to a summit with
a shown elevation of 9430 feet;

Thence northeasterly in a straight line to a point 0.12 mile south
of the north $\frac{1}{4}$ corner of Section 25 T. 41 N., R. 107 W., said
point being on the north-south center line of Section 25;

Thence 0.14 miles south on the Forest boundary;

Thence 0.25 mile east on the Forest boundary;

Thence 0.50 mile south on the Forest boundary;

Thence 0.25 mile west on the Forest boundary;

Thence 0.25 mile south on the Forest boundary;

Thence 0.50 mile east on the Forest boundary to the corner common
to Section 25 and 36, T. 41 N., R. 107 W., and Sections 30 and 31,
T. 41 N., R. 106 W.;

Thence 1.08 mile south on the Forest boundary to the southeast corner
Section 36;

Thence 0.23 mile east on the Forest boundary to its intersection with
the top of a major ridge;

Thence 0.65 mile southwesterly up the top of the ridge to the summit
of a prominent point named Noon Rocks;

Thence 0.5 mile southwesterly in a straight line to a summit with
a shown elevation of 10,691 feet;

Thence 1.65 miles southerly in a straight line to a summit with a
shown elevation of 11,098 feet;

Thence 0.6 mile southwesterly in a straight line to a summit with
a shown contour elevation of 10,600 feet;

Thence 0.6 mile southwesterly in a straight line to a summit with
a shown contour elevation of 10,800 feet;

Thence 0.33 mile southeasterly in a straight line to summit with a
shown contour elevation of 10,680 feet;

Thence 2.92 miles northeasterly in a straight line to the point where
Whiskey Mountain Trail crosses an intermittent drainage of Torrey
Creek, said point located at longitude 109°35'51" latitude 43°25'33";

Thence 0.87 mile southeasterly down the drainage to Torrey Creek,
this point being 0.41 mile up Torrey Creek from where it crosses the
National Forest boundary;

Thence 0.71 mile southeasterly in a straight line to the southwest
corner of Section 22 T. 40 N., R. 106 W.;

Thence 1.0 mile east on the Forest boundary to the southeast corner of Section 22 T. 40 N., R. 106 W.;

Thence 0.29 mile northeasterly in a straight line to a summit with a shown elevation of 9100 feet;

Thence 2.90 miles northeasterly on the hydrographic divide between Blue Hole Creek and Torrey Creek to its intersection with the north line of Section 13 T. 40 N., R. 106 W.;

Thence 0.4 mile east on the Forest boundary to the northeast corner of Section 13 T. 40 N., R. 106 W.;

Thence 2.6 miles south on the Forest boundary to the southwest corner of Section 19 T. 40 N., R. 105 W.;

Thence 1.0 mile east on the Forest boundary to the corner common to Sections 19, 20, 29 and 30, T. 40 N., R. 105 W.;

Thence 1.0 mile south on the Forest boundary to the point of beginning;
