

WILD AND SCENIC RIVER
BOUNDARY DESCRIPTION

Cossatot River, Arkansas

A Wild, Scenic, or Recreational River designation in accordance with Section 2 of the Arkansas Wild and Scenic Rivers Act of 1992 (Public Law 102-275) for those segments of the main stem of the Cossatot River and its Brushy Creek tributary lying within T3S-R29W, T4S-R29W, and T4S-R30W, in Polk County, Arkansas, the corridor for which is more particularly described as follows (parenthetical phrases relate each corner called in this description to the official map):

Beginning at the NW corner of Section 13 in T4S-R30W (POB);

Thence West along section line a distance of approximately 1000 feet to a point (#2);

Thence South a distance of approximately 500 feet to a point on the 1000-foot contour as it crosses a south running drain (#3);

Thence Southerly along the 1000-foot contour a distance of approximately 5200 feet to a point on the south side of a hill in the NE1/4SE1/4 of Section 14 in T4S-R30W (#4);

Thence Southeasterly a distance of approximately 800 feet to the SE1/16 corner of said Section 14 (#5);

Thence Southwesterly a distance of approximately 1400 feet to the property corner just west of the Cossatot River on the north line of Section 23 in T4S-R30W (#6);

Thence Southwesterly a distance of approximately 1000 feet to the property corner 11 chains south of the N1/4 corner of said Section 23 (#7);

Thence Northwesterly a distance of approximately 1450 feet to the property corner 2.5 chains south of the NW corner of the NE1/4NW1/4 of said Section 23 (#8);

Thence North along the property line a distance of 165 feet to said NW corner (#9);

Thence North a distance of approximately 660 feet to the midpoint of the west line of the SE1/4SW1/4 of Section 14 in T4S-R30W (#10);

Thence Westerly a distance of approximately 5280 feet to the midpoint of the east line of the SW1/4SW1/4 of Section 15 in T4S-R30W (#11);

Thence North a distance of approximately 660 feet to the NE corner of said SW1/4SW1/4 (#12);

Thence Southwesterly a distance of approximately 1870 feet to the SW corner of said SW1/4SW1/4 (#13);

Thence Westerly along the north line of Section 21 in T4S-R30W a distance of approximately 4400 feet to a point on the 1000-foot contour (#14);

Thence initially Southerly into said Section 21 along said 1000-foot contour and then through portions of Sections 20 and 17 in T4S-R30W a distance of approximately 18,000 feet to a point on Forest Road 511 (#15);

Thence Northeasterly along Forest Road 511 a distance of approximately 200 feet to a point on the 1000-foot contour (#16);

Thence initially Westerly through said Section 17 along said 1000-foot contour and then through a portion of Section 8 in T4S-R30W a distance of approximately 27,000 feet to a point on the west line of the NW1/4SW1/4 of said Section 8 (#17);

Thence South along said west line a distance of approximately 1000 feet to the SW corner of said NW1/4SW1/4 (#18);

Thence West along the north line of the S1/2SE1/4 of Section 7 in T4S-R30W a distance of approximately 1700 feet to a point on the 1000-foot contour west of Brushy Creek (#19);

Thence initially Southeasterly along said 1000-foot contour through said S1/2SE1/4 of Section 7 and also through portions of Sections 8, 17, and 18 in T4S-R30W a distance of approximately 24,500 feet to a point on the west line of the NW1/4NW1/4 of said Section 18 (#20);

Thence South a distance of approximately 450 feet to the point where the west line of said Section 18 intersects the 1000-foot contour just south of Rock Creek (#21);

Thence initially Easterly along said 1000-foot contour through said Section 18 and also through portions of Sections 17, 19, and 20 in T4S-R30W a distance of approximately 52,000 feet to a point on a ridge in the SW1/4SE1/4 of said Section 19 (#22);

Thence Southeasterly a distance of approximately 1100 feet to the E1/16 corner on the south line of said Section 19 (#23);

Thence East along the south lines of Sections 19 & 20 in T4S-R30W a distance of approximately 6600 feet to the SE corner of said Section 20 (#24);

Thence North along the East line of said Section 20 a distance of approximately 700 feet to a point at the center of Forest Road N76 (#25);

Thence initially Northwesterly and then Easterly along said Road N76 through portions of Sections 20, 21, and 22 in T4S-R30W approximately 6600 feet to a point on the east line of the W1/2SW1/4 of said Section 22 (#26);

Thence North a distance of approximately 1900 feet to a point on the west line of the SE1/4NW1/4 of said Section 22 at County Road 31 (#27);

Thence Easterly along said county road a distance of approximately 1500 feet to a point at the outlet of a drain (#28);

Thence North-Northeasterly up said drain a distance of approximately 1000 feet to a point on the crest of an east-west ridge (#29);

Thence Easterly along said ridge crest a distance of approximately 7500 feet to a point at a transmission line within the NW1/4 of Section 24 in T4S-R30W (#30);

Thence Northwesterly along said transmission line a distance of approximately 2700 feet to a point on the west line of the SW1/4SW1/4 of Section 13 in T4S-R30W (#31);

Thence North along said west line a distance of approximately 500 feet to the NW corner of said SW1/4SW1/4 (#32);

Thence East along the north line of the S1/2SW1/4 of said Section 13 a distance of approximately 2640 feet to the NE corner of said S1/2SW1/4 (#33);

Thence North a distance of approximately 3960 feet to the S1/4 corner of Section 12 in T4S-R30W (#34);

Thence North along the centerline of said Section 12 a distance of approximately 1900 feet to a point on the crest of an east-west ridge (#35);

Thence Easterly along said ridge crest a distance of approximately 2400 feet to a point on the east line of said Section 12 (#36);

Thence North along said east line a distance of approximately 3400 feet to a point on the 1200-foot contour on the north side of Short Creek (#37);

Thence initially Northwesterly along said 1200-foot contour through Section 1 in T4S-R30W, and then through portions of Sections 5, 6, 7, and 8 in T4S-R29W a distance of approximately 15,000 feet to a point on the east line of the W1/2SW1/4 of said Section 5 (#38);

Thence North along the property line and its extension a distance of approximately 2640 feet to the SW corner of the NE1/4NW1/4 of said Section 5 (#39);

Thence East a distance of approximately 1320 feet to the SE corner of said NE1/4NW1/4 (#40);

Thence North a distance of approximately 550 feet to a point on the 1200-foot contour (#41);

Thence Northwesterly along said 1200-foot contour a distance of approximately 2000 feet to a point on the west line of the E1/2SW1/4 of Section 32 in T3S-R29W (#42);

Thence North along said west line a distance of approximately 700 feet to a point on the 1200-foot contour (#43);

Thence initially Northeasterly along said 1200-foot contour through said Section 32 a distance of approximately 9000 feet to a point on Forest Road N38A or its extension (#44);

Thence Northeasterly along said road a distance of approximately 2000 feet to a point on County Road 25-1 (#45);

Thence Northwesterly along said county road a distance of approximately 100 feet to a point on the north line of the W1/2SW1/4 of Section 33 in T3S-R29W or its extension (#46);

Thence West along the property line a distance of approximately 3960 feet to the C1/4 corner of Section 32 in T3S-R29W (#47);

Thence North a distance of 400 feet to a point (#48);

Thence West a distance of approximately 1400 feet to a point on County Road 31 (#49);

Thence Southwesterly along said road a distance of approximately 5400 feet to a point on the north line of the S1/2NE1/4 of Section 6 in T4S-R29W (#50);

Thence West a distance of approximately 1400 feet to the NW corner of said S1/2NE1/4 (#51);

Thence South a distance of approximately 1200 feet to a point at the crest of an east-west ridge (#52);

Thence Westerly along said ridge crest a distance of approximately 4000 feet to a point on the extension of the west line of the E1/2W1/2NE1/4SE1/4 of Section 1 in T4S-R30W (#53);

Thence South along said extension and west line a distance of approximately 1320 feet to the NE corner of the SW1/4SW1/4NE1/4SE1/4 of said Section 1 (#54);

Thence West a distance of approximately 330 feet to the NW corner of said SW1/4SW1/4NE1/4SE1/4 (#55);

Thence South a distance of approximately 330 feet to the SW corner of said SW1/4SW1/4NE1/4SE1/4 (#56);

Thence West a distance of approximately 1320 feet to the NE corner of the SE1/4SW1/4 of said Section 1 (#57);

Thence South along the east line of said SE1/4SW1/4 a distance of approximately 1100 feet to a point on the crest of an east-west ridge (#58);

Thence Westerly and Southwesterly along said ridge crest a distance of approximately 4000 feet to the geodetic monument on the peak of West Hanna Mountain (#59);

Thence South and Southeasterly along the crest of a ridge line a distance of approximately 2200 feet to a point on the east line of Section 11 in T4S-R30W (#60);

Thence South a distance of approximately 1700 feet to the SE corner of said Section 11 and the point of beginning, containing 4,165 acres more or less.
