

**FLATSIDE WILDERNESS
BOUNDARY DESCRIPTION**

All of Flatside Wilderness is located on the Ouachita National Forest in Perry and Saline Counties, Arkansas, within Townships (T.), 2 and 3 North (N.), Ranges (R.) 18 and 19 West (W.), 5th Principal Meridian. This Wilderness designation is in accordance with the Arkansas Wilderness Act of Public Law 98-508, October 19, 1984.

The Boundary is delineated on the U.S.G.S. 1:24,000 scale 7 1/2 minute topographic quadrangles: Alpin, Nimrod SE and Paron SW (Modified for U.S.D.A. Forest Service use). The acreage was obtained by digitizing the Wilderness Boundary from the proceeding named quads using the Arkansas State Plane Coordinate System, North Zone. All distances are map distances that were digitized from the quads named above and therefore should be considered as approximate.

The Wilderness Boundary is more particularly described as follows:

THE POINT OF BEGINNING and Point #1, the Southeast corner of Section 5, T.2N., R.19W.:

Thence west approximately 1,320 Feet To Point #2, the East 1/16 corner on the South line of said Section 5;

Thence north approximately 4,857 Feet to Point #3, the East 1/16 corner on the North line of Section 5, T.2N., R.19W.;

Thence east approximately 20 Feet to Point #3A, the East 1/16 corner on the South line of Section 32, T.3N., R.19W.;

Thence north approximately 2,640 Feet to Point #4, the Center-East 1/16 corner of said Section 32;

Thence east approximately 1,320 Feet to Point #5, the East 1/4 corner of said Section 32;

Thence east approximately 952 Feet along the North line of the West 1/2 of Southwest 1/4 of Section 33, T.3N., R.19W. to Point #6, a point 33 Feet west of and normal to the centerline of Forest Development Road (FDR) 793;

Thence southerly and easterly approximately 1,176 Feet along a line 33 Feet west and south of and parallel with the centerline of FDR 793 to Point #7, a point on the East line of the West 1/2 of Southwest 1/4 of said Section 33;

Thence leaving said road south approximately 528 Feet to Point #8, the Southwest 1/16 corner of said Section 33;

Thence east approximately 250 Feet along the North line of the Southeast 1/4 of Southwest 1/4 of said Section 33 to Point #9, a point 33 Feet west of and normal to the centerline of FDR 793;

Thence southerly approximately 1,381 Feet along a line 33 Feet west of and parallel with the centerline of FDR 793 to Point #10, a point on the South line of said Section 33;

Thence southerly and easterly approximately 21,441 Feet along a line 33 Feet west and south of and parallel with the centerline of FDR 793, through Sections 4, 3, 2, and 1, T.2N., R.19W. to Point #11, a point on the East line of said Section 1;

Thence north approximately 352 Feet along said section line to Point #12, the Northeast corner of said Section 1, being also the Southwest corner of Section 31, T.3N., R.18W.;

Thence north approximately 2,640 Feet to Point #13, the West 1/4 corner of said Section 31;

Thence east approximately 3,379 Feet to Point #14, the Center 1/4 corner of said Section 31;

Thence north approximately 1,320 Feet to Point 15, the Center North 1/16 corner of said Section 31;

Thence east approximately 2,640 Feet to Point #16, the North 1/16 corner on the East line of said Section 31;

Thence north approximately 1,320 Feet to Point #17, the Northeast Corner of said Section 31, also being the Southeast corner of Section 30, T.3N., R.18W.;

Thence west approximately 3,960 Feet to Point #18, the West 1/16 corner on the South line of said Section 30;

Thence north approximately 3,505 Feet along the West line of the East 1/2 of West 1/2 of said Section 30 to Point #19, a point 33 Feet South of and normal to the centerline of FDR 86;

Thence easterly approximately 1,650 Feet along a line 33 Feet south of and parallel with the centerline of FDR 86 to Point #20, a point 33 Feet south of and normal to the centerline of FDR 94;

Thence easterly approximately 5,159 Feet along a line 33 Feet south of and parallel with the centerline of FDR 94 through Sections 30 and 29, T.3N., R.18W. to Point #21, a point on the East line of the Northwest 1/4 of said Section 29;

Thence south approximately 800 Feet to Point #22, the Center 1/4 corner of said Section 29, T.3N., R.18W.;

Thence east approximately 2,640 Feet to Point #23, the West 1/4 corner of Section 28, T.3N., R.18W.;

Thence easterly approximately 4,369 Feet along the North line of the South 1/2 of said Section 28 to Point #24, a point 33 Feet southwesterly of and normal to the centerline of FDR 94;

Thence easterly and southerly approximately 11,305 Feet along a line 33 Feet southerly and westerly of and parallel with the centerline of FDR 94 through Sections 28, 27, and 34, T.3N., R.18W. to Point #25, a point on the South line of said Section 34;

Thence southerly and easterly approximately 6,735 Feet along a line 33 Feet southerly and westerly of and parallel with the centerline of FDR 94 through Sections 3 and 2, T.2N., R.18W. to Point #26, a point 33 Feet westerly of and normal to the center line of the West junction of FDR 132;

Thence southerly and westerly approximately 28,728 Feet along a line 33 Feet westerly and northerly of and parallel with the centerline of FDR 132 through Sections 2, 3, 10, 9, 8, and 7, T.2N., R.18W. to Point #27, a point on the West line of said Section 7, T.2N., R.18W.;


Thence continuing westerly and southerly approximately 20,259 Feet along a line 33 Feet northerly of and parallel with the centerline of FDR 132 through Sections 12, 11, 10, and 9, T.2N., R.19W. to Point #28, a point 33 Feet northeasterly of and normal to the centerline of FDR 124;

Thence westerly and northerly approximately 5,890 Feet along a line 33 Feet northerly and easterly of and parallel with the centerline of FDR 124 to Point #29, a point on the West line of said Section 9;

Thence northerly approximately 1,839 Feet to Point #1, the Northwest corner of said Section 9, being also the Southeast corner of Section 5, T.2N., R.19W., and THE POINT OF BEGINNING.

The Flatside Wilderness containing an aggregate of 9,507 acres more or less.
